Instructions for Model: A51UFO-B Lighting kit to used in the Area 51 U.F.O. AE -341.15B, made Pegasus Hobbies.

This unit is completely assembled and tested. Just plug in the 9 volt battery (not included), slide the micro slide switch On. Then swipe the magnet across the Momentary Speed Adjustment Magnetic Switch to set the different speeds. The unit is small enough to fit exactly between the centers of the UFO's six windows when elevated by 1.5 inch block, (not included) from the floor of the saucer. See the below video link for additional information. Hot glue the bottom of the round board to the 1.5 inch block for locking it in place.

In case you accidentally break one of the wires, the below picture will show you which wire connects to a particular component.


