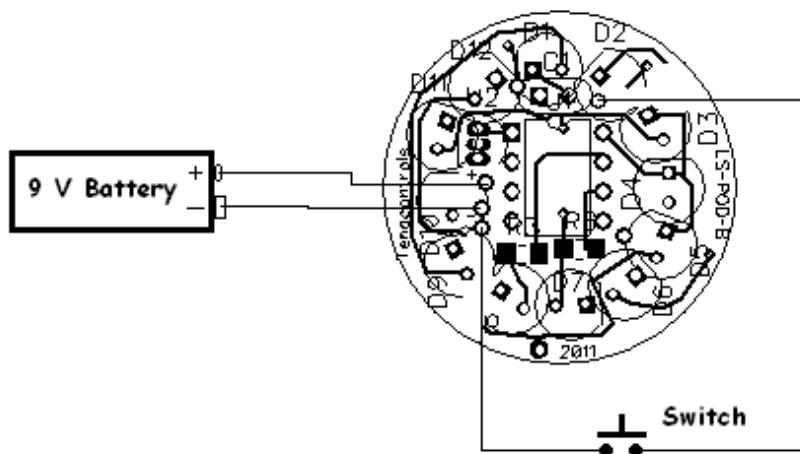
Instructions for the Lost in Space Pod LED Engine Sequencer, which fits the 1/24 scale model made by Moebius

This unit is completely assembled and tested. Just plug in the enclosed 9 volt battery and the push the momentary switch once, this will be the slow rotational speed, push momentary switch again for medium rotational speed, push momentary switch again for fast rotational speed. Then to stop the led engine sequencer from rotating, just press the momentary once more. Silicone glue under the printed circuit works well for locking it in place. Let dry for 12 hours before touching board.

In case you accidentally break one of the wires, the below picture will show you which wire connects to a particular solder pad.

If you rather use a magnetic momentary reed switch, then just remove the supplied momentary switch and use any magnetic momentary reed of your choice. Here is a link from Digikey that explains the theory on how to use reed switches.
